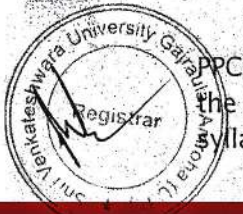
OBJECTIVE

SCOPE OF MOU

1. Shri Venkateshwara University will be responsible for taking admission of all the students in association with PPCMC and consequently awarding a UGC recognized degree of "BJMC & MJMC" to all the students after successful completion of their program.
2. In association with PPCMC, SVU shall be responsible for completing the admission process, issue admission confirmation letter and designating roll numbers to all the students as per the academic process approved by UGC and SVU management board.
3. Shri Venkateshwara University shall be authorizing PPCMC for executing the following tasks at its campus:
 - Promotion, marketing, Branding guest sessions, and workshops, Internships, Job Fairs, and other academic activities as deemed fit for the professional development of the students and may bring better employment perspective for the students.

PPCMC shall be responsible for conducting and organizing the said activities strictly as per the academic calendar approved by SVU & examination shall be conducted as per the syllabus of the course provided, in the University Campus.
